Official Rules & Guidelines
Twas the Lights before Christmas: A “Keep the Cheer Here” Tour

1. There is no entry fee, however, all entrants must submit an entry form, **which must be received by Nov 25.**
2. Displays must be visible from a city, county, or state roadway.
3. By submitting an entry form, you are granting permission to the Todd County Chamber of Commerce to document, photograph and promote your entry in print, radio, social media, and other promotions.
3. Displays must be located on private ground (not necessarily your own) by permission of landowner and should not limit vehicle visibility or in any way cause an obstruction to traffic. The highway/road right-of-way must be observed and not infringed upon.
3. Decoration materials are not limited in any way, shape, or form. Let your imagination run wild!
4. Return entry form no later than Nov 25 to info@toddchamber.com, mail to Todd County Chamber of Commerce, PO Box 505, Elkton, KY 42220; or drop off at the Todd County Welcome Center, 1 Public Square, in Elkton. *Please do **NOT** drop off forms at Elkton City Hall!*
5. **NEW THIS YEAR: YOU MUST SUBMIT YOUR OWN PHOTO OF YOUR DISPLAY FOR VOTING!** Simply take the best possible photo of your display and email it to info@toddchamber.com by 6pm November 30. Photos not submitted by this deadline will not be included in the voting, and therefore not eligible for prizes!
5. The displays with most number of “Likes” on Chamber of Commerce Facebook page on January 1 will be awarded:

1st Place Private Residence: \$150- Chamber Bucks

2nd Place Private Residence: \$100- Chamber Bucks

3rd Place Private Residence: \$50- Chamber Bucks

Top 3 Business/Non-Profit entries will each receive a Trophy

6. **Important Dates: PLEASE NOTE!**

- **November 25: Entry forms must be received by the Todd County Chamber of Commerce.** Entries not received by this date will not be eligible for awards and may be left off the map!
 - **November 30: Display photos must be submitted.** Photos not submitted by this deadline will not be included in the Facebook voting, and therefore not eligible for prizes!
 - **December 1: Entries must be completed and on display. Christmas Light Tour maps will be printed by this time and the Light Tour and Facebook voting officially begins.**
7. An online map will be created and posted online at toddchamber.com to provide visitors with a self-guided tour across Todd County to view the Lights. Printed maps will also be available at the Todd County Welcome Center (including the Visitor Information Kiosk on the courthouse lawn) and at several Chamber Member businesses.
